Curb issues on Mount Mitchell- Getting Quote for the bad area.

Sprinkler issues in butterfly garden- Control boxes were placed on our side of the pond to control the sprinklers in the front of the gate, and the butterfly garden.

Street Maintenance – Seal cracks later in the year when it gets colder. Sealing of the streets will be done next year.

Mulch is washing out of flower beds. No solution yet.

Have one home where they still owe past dues, but they are not aware of the shortage. We are looking at the best way to proceed in collecting.

#### **New Business**

- a. We are still trying to finalize the agreement between GLT and SGLT on the maintenance of the common areas. We are trying to get them finalized so we can vote on them at the community meeting in November.
- b. We need someone to check bathroom supplies in the clubhouse between cleanings.
- c. We will be putting an additional bracing on the gate going to the pool area. This will keep people from being able to get into the pool without a fob.
- d. We are changing the closing procedures for the pool to prevent the algae growth during the winter, which should allow us to be able reopen the pool without the draining and acid wash. 1<sup>st</sup> Phil 2<sup>nd</sup> Jeremy, approved by all
- e. Discussion of flagpole standards in the neighborhood. It is allowed in the bylaws. Approving DRB request, with condition that the pole will be the telescoping type of pole and it does not exceed CC&R height.
