Old Business

Removal of rental fees for the clubhouse. Tabled until budget discussions.

Pool resurfacing – Eric looked and does not believe it needs to be done at this time. Vote to remove from old business. 1st Jeremy 2nd Jim. All

Scopes for Contracts – Add to Landscaping contract

- 1. Fertilizer should be 34-0-0
- 2. Number of Mows should remain at 28 per year
- 3. Equipment must be in Good repair.
- 4. Weed removal should be done monthly from flower beds both residential and common areas.
- 5. Mulch added to be 2 times a year once in spring and once in fall. All residential front yard beds and tree rings.
- 6. Weed control for yards in Feb, May and September. September is Pre-emergent and weed control.
- 7. Cleanup trash in common areas.
- 8. Change payments from 12 to 11 to assist in budgeting. And year end closing.
- 9. Payments should be paid back for services not provided. This will happen in November.
- 10. Grade A mulch vs Grade A Premium Mulch. Disagreements on which. Voted to specify Grade A mulch Passed 4-2

Note that the common areas are not represented correctly on the Statement of work. It needs to be done.

Discussed Jim's document on board conduct. Voted to adopt. 1st Jeremy 2nd Jim. Passed 5-1

Covenant Jim handed out will be revised and passed to the next board for adoption.
